# **AVIATe**

The Assessment of Value (AoV) is an initiative introduced by the FCA which instructs asset managers to evaluate and publish their products' performance and incurred costs to evidence the value delivered to investors.

# **Market Insights**

#### UK

**FCA issued Market Watch 73** which covered the CFD market abuse, talks about their observation, and best practices under key topics highlighted.

**TCFD reporting deadline** has now passed. Firms could have been impacted either from an entity, product or provide on demand reporting from the end of last month.

**Consumer Duty** is less than a month away. The FCA's useful podcast, focusing on outcomes monitoring, gives some good guidance for firms to consider how it gets implemented and monitored.

**SDR Policy Statement** is expected in Q3 and will consist of two elements. Anti green washing requirements and then a year long implementation for the product changes and disclosures requirements.

MAR update expected in the UK. We have already seen some recent minor updates (additional markets, NYSE-regulated exchanges and the six exchange).

# EU

**Value for money** is the equivalent of the assessment of value on the UK with a focus on Consumer Duty. If that goes ahead it is expected in 2024.

**SFDR** came in at the beginning of this year. We are seeing gaps in taxonomy data being provided from vendors. One to monitor until the end of year and potentially consider in next year's reporting.

# **US & Canada**

**T+1 settlements** coming in from the 28<sup>th</sup> May 2024. There are a lot of question marks on how the industry is going to handle this. One to monitor for when industry best practices develop.

#### **Combined Regulations**

EMIR Refit coming in April 2024 and a UK perspective September 2024.

**Uncleared margin rules** mainly closed out now. There was one exception - if you are in the US PR Regulatory Jurisdiction it extends out until the end of August as a different implementation timeframe.

# Hong Kong Regulator

**SFCC future and options** - they have put out some position limits and reporting that is due in at the end of this year.

Keep an eye out for latest key updates on any regulatory updates.
